### Multifamily Energy Efficiency Program

SEMCO's Multifamily Energy Efficiency Program offers rebates for energy-efficient upgrades for multifamily properties. This program also offers no-cost direct installation of showerheads, faucet aerators, and pipe wrap based on water heater fuel type.

### Energy Efficiency Assistance Program

SEMCO's Energy Efficiency Assistance Program reduces financial barriers to energy efficiency and home comfort by providing customers with increased incentives for energy waste reduction upgrades. Participants must be SEMCO ENERGY residential customers and meet the household income levels established (currently 250 percent of poverty level). Renters must have expressed consent from property owner to qualify for upgrades.

*Equipment must be purchased and installed between January 1, 2025, and December 31, 2025. Rebate application must be submitted within 90 days of purchase and by December 31, 2025. Rebate cannot exceed the cost of the energy-efficient improvement.*
